- **SCOTT JACOBS**, Managing Director of Jacobs and Associates, directed from 1995-2001 the influential OECD program on regulatory reform that assessed regulatory governance and RIA programs in the industrialized democracies. He has worked on regulatory impact analysis in over 45 developed and developing countries. Mr. Jacobs edited the 1997 OECD report, *Regulatory Impact Analysis: Best Practices in OECD Countries* that is the one of the most frequently cited authorities in the field. He has written 21 books on regulatory reform and good regulation practices. Among his work are: "Asking the Right Questions: The Design of Training Courses for Regulatory Impact Assessment in Developing Countries" at a conference held by the Centre on Regulation and Competition (CRC), Manchester University in Cape Town. He published in 2004 "Regulatory Impact Assessment and the Economic Transition to Markets" in *Public Money & Management*. He has provided RIA training in the European Commission, Bulgaria, China, Korea, Moldova, Serbia, South Africa, Turkey, and Ukraine.
- **PROFESSOR ANDREA RENDA**, Senior Research Fellow at the Centre for European Policy Studies (CEPS), manages CEPS' Regulatory Affairs Programme. Mr. Renda was Coordinator of the European Network for Better Regulation (ENBR), a 3-year Coordination Action on regulatory impact assessment funded by the European Commission under the FP6 programme. Andrea Renda specializes in regulatory affairs and competition policy with a focus on regulatory impact assessment and the regulation of media and telecom markets. He is the author of many published papers and conference presentations on regulatory impact assessment, industry regulation, comparative law and economics and the law and economics of intellectual property and antitrust/competition policy, inter-firm relationships and consumer protection. He is author of the book "Impact Assessment in the EU. The State of the Art and the Art of the State", published in January 2006. He co-authored the Pilot Study on Administrative Burdens for the European Commission, DG Enterprise, and lectured on the reduction of administrative burdens in several European universities. Mr. Renda is a Lecturer of "Economic Analysis of Law", "Competition Law and Economics" and "EU policymaking" at Luiss Guido Carli University. He also lectures on "Advanced Topics in Competition and Regulation" at the Erasmus University of Rotterdam within the European Master in Law and Economics.

- **DR. CESAR CORDOVA** is an international expert on regulatory reform and good governance issues who has advised governments of more than 20 developed or in-transition countries. Since joining Jacobs and Associate as director in January 2004, he has worked with the governments of Albania, Belgium, Bosnia, Bangladesh, Canada, Jordan, Macedonia, Mexico, Moldova, Paraguay, Peru, El Salvador, Serbia, Syria, Turkey, and Vietnam on RIA and regulatory reform aspects. In parallel, he has worked with the World Bank, the Inter American Development Bank, the Asian Development Bank and the International Labour Organization on horizontal issues concerning the setting up of an institutional architecture to drive systemic reforms, the assessment of regulatory burdens and policies through RIA, the improvement of regulatory compliance through effective inspection system, and the strengthening the governance of sectoral autonomous regulators. As deputy head of the OECD Program on Regulatory Reform until 2003, he worked with 30 OECD countries in cutting-edge regulatory design. He directed the OECD country review program – coordinating programs between the OECD and APEC and South East European countries. Prior to joining the OECD, he was the General Director for the Economic Deregulation Unit within the Mexican government and was a negotiator of the North American Free Trade Associations (NAFTA). He has authored many articles and books on regulatory reform and good governance in OECD countries, Latin America, and South East Europe. Dr. Cordova has a French and Mexican nationality.
- **WIM JANSEN** is Deputy Director of the Regulatory Reform Group of the Ministries of Economic Affairs and Finance in the Netherlands. Within the Management Team he is responsible for international co-operation, methodologies and planning and control. Wim is an economist from Tilburg, who has been working on different areas within the ministry of economic affairs such as Economies in Transition (Central and Eastern Europe), Trade Policy, Competition, and Regulatory Reform.
